The detailed scrutiny of the eligibility of the candidate would be done at this stage of the recruitment process. The candidates are advised to bring all the required certificates, DOB (Matriculation Certificate), State Subject (PRC), Qualification Certificates, Category Certificate (if applicable) and NOC for in-service candidate of Police / other services and other certificates has to be provide as per notifications.

As such, the candidature of the candidate shall remain provisional till detailed scrutiny is undertaken and the candidate is found eligible in all respects. J&K Police would be at liberty to reject any application at any stage of the recruitment process, if the candidate is found ineligible for the post or if it comes to notice that the candidate has furnished false information. The decision of the J&K Police shall be final in deciding the eligibility of the candidate.

The mere fact that a Provisional Admit Card has been issued to the candidate will not imply that his/her candidature has been finally cleared or that entries made by the candidate in his/her application has been accepted as true and correct.

- This Admit Card given to you for limited purpose of admitting your entry for the PET/PST only and does not confer any right upon you in any manner regarding selection as constable in SDRF.
- Please check the Provisional Admit Card carefully for your Registration Number, Name and other particulars. In case of any mistake or discrepancy, please communicate with the Nodal Officer of your Recruitment Centre immediately for necessary action.
- You must bring Admit Card with you on the date, time and venue specified in this Admit Card. Failure to bring this may render you ineligible to appear in the above mentioned Tests.
- The Candidates must also bring a photo identity Proof (Diving License, Aadhar Card, voter ID, Passport etc.) in original to establish his identity.
- The Candidates are advised to take out legible printed copy of Admit Card, so that photo and signatures are clearly visible and that the same can be verified. Fudged / blurred admit cards are not admissible.
- No request for any date change of PET/PST Venue shall be entertained under any circumstances. You are responsible for safe custody of the Admit Card and in the event of any other person using it, the onus lies on you to prove that you have not used the service of any impersonator.

Any infringement of these instructions may cancel the candidature of the Candidate and also invite legal action, including a ban from future recruitment in J&K Police. If someone is found violating these instructions, he will be liable to penal action under RANBIR Penal Code and such prohibited items will also be liable for confiscation.
